Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school from class I to XII shall be restricted to 16 of which not more than 1/3rd sections may be used for senior secondary classes. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	The school does not have railing on ramp at ground level and ramp on upper floor has railing only one sides. Thus, the school is required to install the railing on both sides of the ramp at ground level as well as upper floors within 03 months and submit the compliance.
3	The mathematics lab is under stocked and temporarily arranged with insufficient storage and seating facility. Thus, the school is required to upgrade the same as per Board's SoP within 03 months and submit the compliance
4	The Composite science lab is set-up on the make-shift wooden tables. It does not have permanent fixtures, washbasin (with water tap) as well as gas connection in the

	workstation, seating arrangement (wooden stools), sufficient storage facility and safety features such as fire extinguisher and exhaust fan. Further, there are plastics tools are placed for seating instead of wooden stools. Thus, the school is required to set-up in light of Board's SoP within 03 months and submit the compliance.
5	The school is required to install the door at the main entrance of the toilets within 03 months and submit the compliance.
6	The Physics lab is set-up on the make-shift tables and the chemistry lab does not have the exhaust fan and gas connection (in workstations). Further, there are plastics stools are placed in all the three science lab instead of wooden stools. Thus, the school is required to upgrade the in light to the Board's SoP within 03 months and submit the compliance.
7	The school is required to upgrade the indoor and outdoor game (with permanent courts) facilities in light of the Board's SoP within 03 months and submit the compliance.
8	The school is required to upgrade the library with more books and maintain the accession register properly within 03 months and submit the compliance
9	The school shall conduct training of its teachers with CoE Prayagraj within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye - Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

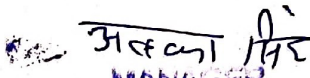
